Operation Access currently serves uninsured individuals in seven San Francisco Bay Area counties: Alameda, Contra Costa, Marin, Napa, San Francisco, San Mateo, and Sonoma who are unable to pay for care and are ineligible for coverage through public insurance programs. Pilot programs exist to serve patients in two additional counties: Santa Clara and Solano. Technical assistance is also provided to communities throughout the country to replicate and advance projects for which Operation Access has valuable expertise. Referrals were received from over 70 community health centers; services were provided by 1,568 medical volunteers, 20 medical groups, and 43 hospitals and ambulatory care centers. The Organization arranged for 1,379 outpatient surgical procedures and diagnostic services for eligible patients in 2014.
