

Operation Access currently serves uninsured individuals in nine San Francisco Bay Area counties: Alameda, Contra Costa, Marin, Napa, San Francisco, San Mateo, Santa Clara, Solano, and Sonoma who are unable to pay for care and are ineligible for coverage through public insurance programs. Technical assistance is also provided to communities throughout the country to replicate and advance projects for which Operation Access has valuable expertise. Referrals were received from over 75 community health centers; services were provided by over 1,500 medical volunteers, 24 medical groups, and 47 hospitals and ambulatory care centers. The Organization arranged for 1,641 outpatient surgical procedures and diagnostic services for eligible patients in 2015.
